## Limited rebate program for Glyxambi®, Jardiance®, Synjardy®, Synjardy® XR, and Trijardy® XR

Boehringer Ingelheim has informed us that they will be **reducing the WAC price for Glyxambi, Jardiance, Synjardy, Synjardy XR, and Trijardy XR, effective January 1, 2026.**

To support customers during this transition, we are pleased to share that Boehringer Ingelheim will be offering a limited rebate program for eligible purchases made between December 14 and December 27, 2025.

### Limited rebate program details:

<b>Eligible purchases</b>	<ul style="list-style-type: none"><li>Non 340B purchases made between December 14 and December 27, 2025. Purchase date is defined as order date.</li><li>Eligibility will also be based on trade classification and includes:</li></ul>

<b>Ineligible purchases</b>	<ul style="list-style-type: none"><li>Units for which Boehringer Ingelheim effectuated a rebate pursuant to the Medicare Drug Price Negotiation Program using 2025 WAC through an adjustment (raised via a Good Faith Inquiry) are ineligible for the limited rebate program.</li></ul>		
<b>Rebate</b>	<ul style="list-style-type: none"><li>Boehringer Ingelheim will review purchases to determine the credit amount. Claims must contain complete information. Submissions, for which we are required to blind, block, or otherwise exclude store-level information are not eligible.</li><li>The credit amount will be calculated as: (Quantity purchased between 12/14/25 and 12/27/25 – quantity rebated through MFP) x (Old Purchase price – New Purchase Price).</li></ul>		
<b>Credit issuance</b>	<ul style="list-style-type: none"><li>Credits will be issued to eligible customers via AmerisourceBergen.</li><li>The credits will be issued in March of 2026. Timing may vary depending on the completion of each step, including verification of eligibility, calculation of purchases and processing.</li></ul>

### Planning your returns:

If you have inventory to return, you should begin the return process now. Ensure your return request is submitted and product is physically returned to your AmerisourceBergen distribution center **before December 14**. AmerisourceBergen **will not accept returns of these products December 14 through January 2, 2026**. Product returned after January 2, regardless of when purchased, will be credited at the lower price.
